5.1 (e) In case of any change in the Consortium Member of the Consortium, an amended Consortium Agreement shall be submitted to the authority by the Lead Member.

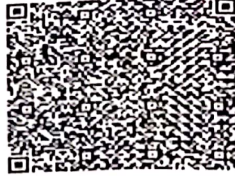
