## UNDERTAKING

1. The Project Land is owned by M/s Samarpit Constructions Private Limited vide Sale Deed dated 19.05.2012 registered at the office of the Sub-Registrar vide Book No -1, Jild No. 14255 at pages 189 to 294.
