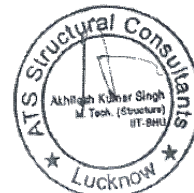

- We estimate the Total Cost for completion of the project under reference Rs. 2236 Lakh (**approx**) (Total of S. No. 1 in Tables A and B) including cost of development of common facilities. 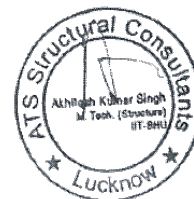

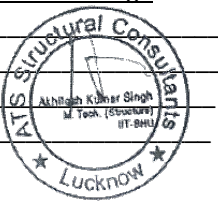
