We estimate the Total Cost for completion of the project under reference as Rs. 33,79,46,180/- (cost has been further increased from Rs. 32.233 crores to Rs. 33.795 Crores due to increase in steel price and other covid effect in cost) (Total of S.No. 1 in Tables A and B) including cost of development of common facilities. The estimated Total Cost of project is with reference to the Civil, MEP and allied works required to be completed for obtaining occupation certificate/completion certificate for the building(s) from the concerned Competent Authority under whose jurisdiction the previously mentioned project is being implemented.
