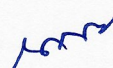

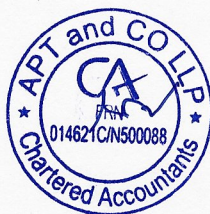

2. Based upon the management confirmation and ambiguity in UP RERA, Land cost has been taken on the actual cost incurred basis.
3. Budgeted cost of the project has been estimated by the management.
4. For the issuance of the above certificate, we have relied on the previously issued CA certificate dated 09th January 2026, covering the details and information up to 31st December 2025. We have only verified the transaction covering the period 1st January 2026 to 31st March 2026 on a sample basis and compiled the certificate figures i.e. amount incurred till 31st March 2026.
5. During the current quarter, the company has recognized ₹217.77 lakhs as land cost paid to the Greater Noida Industrial Development Authority. For FY 2024–25, the amount stands at ₹629.17 lakhs, and for FY 2025–26, it is ₹930.29 lakhs. Out of this, ₹629.17 lakhs for FY 2024–25 has been included under security deposits, while ₹930.29 lakhs for FY 2025–26 has been classified under the loan account.
