This is to certify that I have undertaken assignment of certifying the estimated cost and expenses incurred on actual on site construction till the 30th day of June, 2025 for the Real Estate Project mentioned above.

2. The project is new. We have estimated the cost of the completion of the civil, MEP, infrastructure services and allied works, of the project development. Our estimated cost calculations are based on the drawings/plans made available to us for the project under reference by the Promoter/ Developer and Consultants and the Schedule of items and quantity for the entire work as calculated by Quantity Surveyor appointed by the Promoter, and the fair assumption of the cost of material, labour and other inputs made by developer, and the site inspection carried out by us.
3. We estimate the Total Cost for completion of the project under reference as Rs. 42.50 Crores (Total of S.No. 1 in Tables A and B) including cost of development of common facilities. The estimated Total Cost of project is with reference to the Civil, MEP, infrastructure services and allied works required to be completed for obtaining occupation certificate/completion certificate for the said development from the concerned Competent Authority under whose jurisdiction the previously mentioned project is being implemented.
4. The estimated actual cost incurred till 30.06.2025 is calculated at Rs. 40.65 Crores (Rupees Fourty Crores and Sixty-Five Lacs Only) (Total of S. No. 2 in Tables A and B). The amount of Estimated Cost Incurred is calculated based on amount of Total Estimated Cost.
5. The Balance cost of Completion of the Civil, MEP, infrastructure services and Allied works of the said development of the subject project to obtain Occupation Certificate/Completion Certificate from the Competent Authority is estimated at Rs. 1.84 Crore (Total of S.No. 4 in Tables A and B).
6. I certify that the Cost of Civil, MEP, infrastructure services and allied work for the aforesaid Project as completed on the 30.06.2025 date is as given in Tables A and B below.

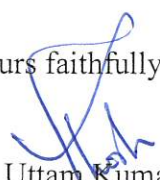
