 - a) That Rs 5513.23 Lacs (Total project cost incurred Rs. 5529.68 lakhs - Amount due to billers/vendors/contractors Rs. 16.45 lakhs) has been actually spent on the on land, construction and development of the project and has not been spent on any item other than the purpose given in Section 4(2)(1)(d) and is, therefore, admissible for withdrawal from Separate Account
 - b) That Rs. 16.45 lakhs is the amount for which bills/invoices from the billers/vendors/contractors have been received for the work already rendered by them for the land, construction and development of the project being due for payment, are therefore, admissible for payment from Separate Account directly to the billers/vendors/contractors in their bank account as per attached list.
5. As stated by the promoter due to changing market conditions, inflation and fluctuations in material prices, the project cost got increased significantly. As such, the total estimated cost of the project is now changed from Rs. 5220 Lakhs to 5770 Lakhs. The promoter is in process to submit an application before Authority. Promoter takes full responsibility in this regard.
6. The amount actually withdrawn as mentioned in Point 10 above is calculated as 70% amount to be deposited in Designated account (Point 8) less Balance in Designated account (Point 11) less FDR amount of Rs. 343 lakhs created from balance in Designated account.

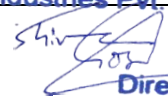
