1. TERMS:

1.1.1 Subject to the terms and conditions as detailed in this Agreement, the Promoter agrees to sell to the Allottee and the Allottee hereby agrees to purchase, the [Apartment/Plot] as specified in para G.

1.5	The promoter may allow, in its sole discretion, a rebate for early payment of instalment payable by the allottee by discounting such early payments @ _____ per annum for the period by which the respective instalment has been preponed. The provision for allowing rebate and such rate of rebate shall not be subject to any revision/withdrawal, once granted to an allottee by the promoter.
1.6	It is agreed that the promoter shall not make any additions and alterations in the sanction plans, layout plans and specifications and the nature of fixtures, fittings and amenities described herein at Schedule 'E' (which shall be conformity with the advertisement, prospectus etc., on the basis of which sale is affected) in respect of the Apartment, plot or building, as the case may be without the previous written consent on the allottees as per the provisions of the Act:

1.7	[Applicable in case of apartment] The promoter shall confirm to the final carpet area that has been allotted to the allottee after the construction of the building is complete and the completion/occupancy certificate (as applicable) * is granted by the competent authority, by furnishing details of the changes, if any in the carpet area. The total payable for the carpet area shall be recalculated upon confirmation by the promoter. If there is any reduction in the carpet area then the promoter shall refund the excess money paid by allottee within forty-five days with annual interest at the rate prescribed in the rules, from the date when such an excess amount was paid by the allottee. If there is any increase in the carpet area. Which is not more than three percent of the carpet area of the apartment, allottee to allottee the promoter may demand that from the allottee as per the next milestone of the payment plan as provided in schedule C. all these monetary adjustments shall be made at the same rate per square/meter foot as agreed in para 1.2 of this agreement.
1.8	Subject to para 9.3 to the promoter agrees and acknowledges, the allottee shall have the right to the [Apartment/Plot] as mentioned below;

(i)	The allottee shall have exclusive ownership of the [Apartment/plot];
(ii)	The allottee shall also have undivided proportionate share in the common areas, Since the share/interest of allottee in the common areas is undivided and cannot be divided or separated. The allottee shall use the common area along with the occupant, maintenance staff etc. without causing any inconvenience or hindrance to them, it is clarified that the promoter shall hand over the common areas to the association of allottees after duly obtaining the completion certificate from the competent authority as provided in the Act.
(iii)	That the computation of the price of the [Apartment/plot] includes recovery of price of land, construction of [not only the Apartment but also] the common areas, internal development charges, external development charges, taxes, costs of providing electric wiring , electrical connectivity to the apartment, lift, water line and plumbing finishing with paint, marbles, tiles, doors, windows, fire detection and firefighting equipment in the Common areas, maintenance charges(as per para 11 etc) and includes cost for providing all other facilities, amenities and specification to be provided within the [Apartment /plot] and the project;

1.9	It is made clear by the promoter and the Allottee agrees that the [Apartment/Plot] along with garage/covered parking shall be treated as a single indivisible unit for all purposes. It is agreed that the project is an independent, self-contained project covering the said Land and is not a part of any project or zone and shall not form a part of and/or linked/combined with any other project in its vicinity or otherwise except for the purpose of integration of infrastructure for the benefit of the Allottee. It is clarified that Project's facilities and amenities <u>other than declared as independent areas in deed of declaration</u> shall be available only for use and enjoyment of the Allottees of the project.
1.10	The promoter agrees to pay all outgoing before transferring the physical possession of the apartment to the allottees, which it has collected from the allottees, for the payment of outgoing (including mortgage loan and interest on mortgage or other encumbrances and such other liabilities payable to competent authorities, banks and financial institutions, which are related to the project). If the promoters fail to pay all or any of the outgoing collected by it from the allottees or any liability, mortgage loan and interest thereon before transferring the apartment to the allottees, the promoter agrees to be liable, even after the transfer of the property, to pay such outgoing and penal charges, if any, to the authority or person to whom they are payable and be liable for the cost of any to the authority or person.

Similarly, the Allottee shall make timely payments of the <u>instalment and other dues payable by him/her and meeting the other obligations under the Agreement subject to the simultaneous completion of construction by the Promoter as provided in Schedule C ("Payment Plan")</u>.</p>
6.	<p>CONSTRUCTION OF THE PROJECT:</p>



	<p>The Allottee has seen the proposed layout plan, specifications, amenities and facilities of the [Apartment/Plot] and accepted the floor plan, payment plan and the specifications, amenities and facilities [annexed along with this Agreement] which has been approved by the competent authority, as represented by the Promoter. The Promoter shall develop the Project in accordance with the said layout plans, floor plans and specifications, amenities and facilities. Subject to the terms in this Agreement, the Promoter undertakes to strictly abide by such plans approved by the competent Authorities and shall also strictly abide by the bye-laws, FAR and density norms and provisions prescribed by the _____ [Please insert the relevant State laws] and shall not have an option to make any variation/alteration /modification in such plans, other than in the manner provided under the Act, and breach of this term by the Promoter shall constitute a material breach of the Agreement.</p>
7.	<p>POSSESSION OF THE APARTMENT PLOT:</p> <p>7.1 Schedule for possession of the said [Apartment/Plot] The Promoter agrees and understands that timely delivery of possession of the [Apartment/Plot] to the Allottee and the Common Areas to the association of Allottees or the competent authority, as the case may be, is the essence of the Agreement. The Promoter assures to hand over possession of the [Apartment/Plot] along with ready and complete Common Areas with all specifications, amenities and facilities of the Project in place on unless there is delay or failure due to war, flood, drought, fire, cyclone, earthquake or any other calamity caused by nature affecting the regular development of the real estate project ("Force Majeure"). If, however, the completion of the Project is delayed due to the Force Majeure conditions then the Allottee agrees that the Promoter shall be entitled to the extension of time for delivery of possession of the [Apartment/Plot]:</p> <p>Provided that such Force Majeure conditions are not of a nature which make it impossible for the contract to be implemented. The Allottee agrees and confirms that, in the event it becomes impossible for the Promoter to implement the project due to Force Majeure conditions, then this allotment shall stand terminated and the Promoter shall refund to the Allottee the entire amount received by the Promoter from the allotment within 120 days from that date. The Promoter shall intimate the Allottee about such termination at least thirty days prior to such termination. After refund of the money paid by the Allottee, the Allottee agrees that he/she shall not have any rights, claims etc. against the Promoter and that the Promoter shall be released and discharged from all its obligations and liabilities under this Agreement. <u>In case the project is developed in phases, it will be the duty of the promoter to maintain those common areas and facilities which are not complete and handover all the common areas and facilities to the RWA once all phases are</u></p>



		completed. The promoter shall not charge more than the normal maintenance charges from the allottees.
7.2	Procedure for the taking possession	The Promoter, upon obtaining the completion certificate*/Occupancy certificate (as applicable) from the competent authority shall offer in writing the possession of the [Apartment/Plot], to the Allottee in terms of this Agreement to be taken within two months from the date of issue of completion certificate/occupancy certificate (as applicable): [Provided that, in the absence of Applicable Law the conveyance deed in favour of the Allottee shall be carried out by the Promoter within 3 months from the date of issue of completion certificate/occupancy certificate (as applicable)]. The Promoter agrees and undertakes to indemnify the Allottee in case of failure of fulfilment of any of the provisions, formalities, documentation on part of the Promoter. The Allottee, after taking possession, agrees to pay the maintenance charges as determined by the Promoter/association of Allottees, as the case may be after the issuance of the completion certificate/ occupancy certificate (as applicable) for the Project. The Promoter shall hand over the completion certificate/ occupancy certificate (as applicable) of the apartment/plot, as the case may be, to the Allottee at the time of conveyance of the same.
7.3	Failure of Allottee to take Possession of [Apartment/Plot]	- Upon receiving a written intimation from the Promoter as per Para 7.2, the Allottee shall take possession of the [Apartment/Plot] from the Promoter by executing necessary indemnities, undertakings and such other documentation as prescribed in this Agreement, and the Promoter shall give possession of the [Apartment/Plot] to the Allottee. In case the Allottee fails to take possession within the time provided in para 7.2, such Allottee shall be liable to pay to the promoter holding charges at the rate of Rs. 2/- per month per sq. ft. of carpet area (in case of apartment) and at the rate of Rs. 1/- per month per sq. ft. per month of plot area (in case of plot) for the period beyond 3 months till actual date of possession in addition to maintenance charges as specified in para 7.2
7.4	Possession by the allottee	- After obtaining the completion certificate/occupancy certificate (as applicable) and handing over physical possession of the [Apartment/Plot] to the Allottees, it shall be the responsibility of the Promoter to hand over the necessary documents and plans, including Common Areas, to the association of Allottees or the competent authority, as the case may be, as per the <u>Applicable law</u> : [Provided that, in the absence of any <u>Applicable Law</u> , the Promoter shall handover the necessary documents and plans, including Common Areas, to the association of Allottees or the competent authority, as the case may be, within thirty days



		after obtaining the completion certificate/occupancy certificate (as applicable)].
	7.4	<p>Cancellation by the allottee - The Allottee shall have the right to cancel/withdraw his allotment in the Project as provided in the Act: Provided that where the Allottee proposes to cancel/withdraw from the Project without any fault of the Promoter, the Promoter herein is entitled to forfeit the booking amount paid for the allotment. The promoter shall return 50% (fifty percent) of the balance amount of money paid by the allottee within 45 (Forty-five) days of such cancellation / withdrawal and the remaining 50% (fifty percent) of the balance amount on re-allotment of the apartment / plot or at the end of one year from the date of cancellation / withdrawal by the allottee, whichever is earlier. The promoter shall inform the previous allottee the date of re-allotment of the said apartment / plot and also display this information on the official website of UP RERA on the date of re-allotment.</p>
	7.6	<p>Compensation - The Promoter shall compensate the Allottee in case of any loss caused to him due to defective title of the land, on which the Project is being developed or has been developed, in the manner as provided under the Act and the claim for interest and compensation under this provision shall not be barred by limitation provided under any law for the time being in force. Except for occurrence of a Force Majeure event, if the Promoter fails to complete or is unable to give possession of the [Apartment/Plot] (i) in accordance with the terms of this Agreement, duly completed by the date specified in Para 7.1; or (ii) due to discontinuance of his business as a developer on account of suspension or revocation of the registration under the Act; or for any other reason; the Promoter shall be liable, on demand to the Allottees, in case the Allottee wishes to withdraw from the Project, without prejudice to any other remedy available, to return the total amount received by him in respect of the [Apartment/Plot], with interest at the rate prescribed in the Rules including compensation in the manner as provided under the Act within forty-five days of it becoming due: Provided that where if the Allottee does not intend to withdraw from the Project, the Promoter shall pay the Allottee interest at the rate prescribed in the Rules for every month of delay, till the handing over of the possession of the [Apartment/Plot], which shall be paid by the Promoter to the Allottee within forty-five days of it becoming due.</p>

(iii)		There are no encumbrances upon the said Land or the Project; [in case there are any encumbrances on the land provide details of such encumbrances including any rights, title, interest and name of party in or over such land]
(iv)		There are no litigations pending before any Court of law or Authority with respect to the said Land, Project or the [Apartment/Plot];

(viii)		The Promoter confirms that the Promoter is not restricted in any manner whatsoever from selling the said [Apartment/Plot] to the Allottee in the manner contemplated in this Agreement;
(ix)		At the time of execution of the conveyance deed the Promoter shall handover lawful, vacant, peaceful, physical possession of the [Apartment/Plot] to the Allottee and the Common Areas to the association of Allottees or the competent authority, as the case may be;
(x)		The Schedule Property is not the subject matter of any HUF and that no part thereof is owned by any minor and/or no minor has any right, title and claim over the Schedule Property;

		After the Promoter executes this agreement he shall not mortgage or create a charge on the [Apartment/Plot/Building] and if any such mortgage or charge is made or created then notwithstanding anything contained in any other law for the time being in force, such mortgage or charge shall not affect the right and interest of the Allottee who has taken or agreed to take such [Apartment/Plot/Building].
