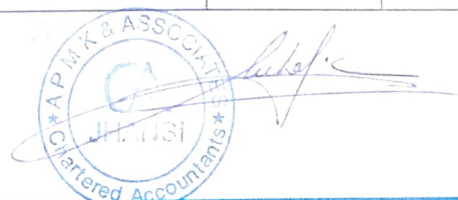

For the purpose of calculating the withdrawal limit, revised estimated cost as provided by the promoter has been taken into account. The promoter has undertaken all responsibilities in this regard.
